Nuclear Disarmament

When the committee began, the delegates were given 15 minutes of an unmoderated caucus to finish their working paper. 31 delegates were present in the committee. The delegates of India, Pakistan, Russia and the USA were barred from the committee for 5 minutes because they formed a working paper of the completely unlikely kind. The delegate of South Sudan presented an elaborate resolution soon after presenting his working paper. The resolution was called 'Modern Problems Require Modern Solutions'. The resolution urged the reduction of nuclear arsenals of countries that have them. It suggests improvements to the powers of the IAEA, so that the denuclearisation



debate is done entirely by them and an entire body focuses on nuclear weapons solely. The resolution also tackles the climate change debate by dismantling of nuclear weapons and using those parts for nuclear energy instead. The IAEA is the primary organisation responsible for nuclear security. The resolution proposes that IAEA have representatives from all countries that wish to be a member. No country in the IAEA has veto power. The delegate of



China asked the delegate of South Sudan what measures have been taken to know that IAEA is not a corrupt body if it is an unmoderated organisation. The delegate of South Sudan motioned for the voting of the resolution he introduced. Out of 31, all delegates were present and voting. In the first round of voting for the resolution proposed by the delegate of South Sudan, 24 delegates voted Yes, 3 delegates voted Yes With rights,

1 delegated voted for Pass, 2 delegates voted No, and another abstained. In the second round of voting, there was 100% agreement for the resolution which resulted in it's passing. The delegate of Azerbaijan motioned for a discussion of the relations between India and the USA. This led to a heated debate between the delegate of the USA and the delegate of India who were joined by the delegates of Pakistan and South Sudan respectively.

DISEC was the first out of five committees to successfully pass a resolution.

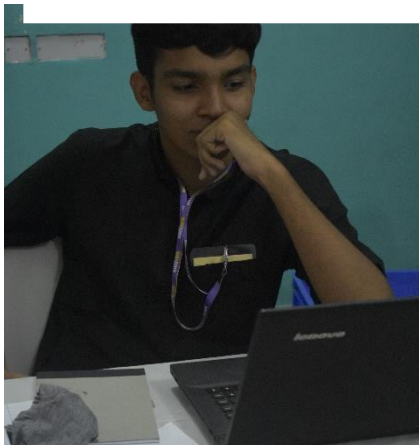

After the passing of the motion to move into a moderated caucus on the topic of Kashmiris' views and solutions regarding Article 370, the Chairs, granted 15 minutes to an informal debate wherein the delegate of SDF 1 stated the incompetence of the INC to bring about any changes for the development of the nation when they were in power.

The delegate of INC 6 and the delegate representing Narendra Modi had a very powerful verbal war resulting in both the delegates getting barred from the committee for 5 minutes.



Towards the end of the session, a motion was passed to present a bill made by the INC, followed by a motion passed to discuss the bill. The committee caught up and succeeded in passing the bill unanimously. The committee was adjourned.
